We also have other projects and have partnered with other organizations such as Valley Vision. An example of that would be the Northstate Planning & Development Collaborative.  - (3) Q: To clarify: as part of the process, are we going to be identifying growing industry sectors and creating strategies for workforce development?
 - (4) Evan- Yes, that's a piece of it. We want to know where our market sectors are and create pathways to those sectors while also thinking about recovery and resiliency, sustainability, etc.

- b. There are intersections and that could be useful for us to recognize those. What makes a region unique are the assets in the communities. Recognizing this helps us open up to other players who are not typically included in the creation of these economic plans

- c. In terms of resilence What are the problems or how can we redirect a problem into an opportunity? What are the losses going to be and what do we need to do to transition people out of sectors and into new ones. I am worried about the

- impact on homelessness these transitions can have, especially when we think about droughts, fires, etc. We need to make sure we can react to the climate and make that part of our strategy for the clean economy.
- d. I've been hearing a lot about the circular economy but much of it is from a top-down perspective. I want to open up to a bottom-up approach. We really just need to talk to the communities neighborhood by neighborhood because they know what they need.
- e. Q: Is there anything from the state about how projects will be evaluated? Some indicators change quickly and some take years. It may be difficult to link projects to indicators.
 - i. A: It will be difficult and it will require the state to provide more guidance as we get closer to the implementation phase. It will also require us to have processes that really bring community members into this
- f. Just wanted to also share that United Ways of California has developed the California Real Cost Measure. Unlike the official poverty measure which primarily accounts for the cost of food, the Real Cost Measure factors the costs of housing, health care, child care, transportation and other basic needs to reveal what it really costs to live in California. https://www.unitedwaysca.org/realcost
